Although the need for email archiving has been largely driven by need to meet appropriate legislation as email volumes have increased with around 90% of business now transacted via email businesses are now seeing the benefit of email archiving as a management tool .

### Regularity Needs

Organisations face an ever growing set of regulations that have a direct impact on the use, management and control of emails. Regulations may be Industry

specific or generic such as with the Data Protection and Human Rights Acts, in both cost effective email storage and management is an effective way of protecting the interests of a business by reducing exposure to spurious claims or in supporting one's own case.

### Watching the watcher

Audit trails are essential with regards to complying with the needs of the Data Protection. In particular Principle 7 of the Act that requires a second level of authority and audit trails to watch over the activities of the data manager/controller.

**Cryoserver** implements three levels of users to ensure compliance plus the system administrator who has no access to emails

- ❖ Email user (employee)
- ❖ Privileged User (data) manager who sets policies and watches over the email users
- ❖ Data Guardian who watches over and can replay the activities of the Privileged User

## Software Modules

### PST Import:

An Import utility that scans the network for .pst and .ost files which then copies or moves them to a central location and then imports these files in to Cryoserver removing any duplicates.

### Single Sign On

Authenticates users against the Directory so users can directly access the Cryoserver archive from outlook with out a second logon

### Exchange Import Utility

The Cryoserver Import Utility now allows you to import current & legacy emails directly from the Exchange server to Cryoserver, based on mailbox, size of email and date ranges. A simple user interface runs on the Exchange server allowing you to browse the entire mail-store and select which mailboxes.

### Exchange Stubbing

Replaces emails in the Exchange store with a stub containing a message summary and a hot link to the email in the archive.
